Community Engagement Committee

The committee met on 26th September.

<u>Platinum Jubilee Clock</u> – the clock was successfully installed on 21^{st} September and has mainly been in receipt of very positive feedback from the public. The committee agreed the clock should forever be known as the Queen Elizabeth II Platinum Jubilee Clock.

The committee agreed a small dedication ceremony should be held on Sunday, 6th November.

Discussions around the wording of a plaque and planting around the base of the clock are underway.

<u>Merchant Navy Day, 3rd September</u> – a small and successful event had taken place by the war memorial at 10am, during which the Red Ensign was raised.

<u>Emergency Services Day, 9th September</u> – the planned event was cancelled owing to the death of Her Majesty, Queen Elizabeth II. Cllr Toney reported he had heard Emergency Services Day was possibly going to be held later in the year.

<u>Half-term playscheme</u> – all is progressing for another half-term playscheme to run on Wednesday, 26th October.

Blue plaques – further discussion of some proposals for additional blue plaques in the village were deferred pending discussion by the Environmental Initiatives Working Party to create a map or walking route taking in the village's historic buildings.

A proposal from a member of the public to have a series of non-blue plaques marking the homes of notorious criminals was turned back to the member of the public asking him to suggest the sites where such plaques could be installed.

2023/24 Budget – the committee drafted an initial budget for the coming financial year. Unless further changes are made, the proposed budget is an increase of just £2,100 on the current year's budget.

2023 Calendar – Cllrs Chapman and Duff believed they were close to being ready to going to print with a 2023 Calendar. Please see Agenda Item below about funding this project. Thanks.

"On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return, in our opinion the information in Sections 1 and 2 of the Annual Governance and Accountability Return is in accordance with the Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislations and regulatory requirements have not been met."

Other matters not affecting our opinion which we draw to the attention of the authority: "The Annual Internal Audit Report was initially submitted without an answer to Assertion I. This was resubmitted by the Internal Auditor when queried with a 'Yes' answer. This answer was in line with expectations and so there is no further concern in relation to this area."

18. October meetings and events

1. Introduction

This is the report mainly covering September 2022 and matters which may not arise elsewhere on the agenda.

2. Police matters

The council has had some contact with Sussex Police in the past month relating to allegations of drug dealing from a local shopfront business. Progress on this has been slower than usual for a number of reasons.

3. Anti-social behaviour matters

A resident called in on 20th September and reported youths had built a den on land adjacent to Flint Close and Mill Pond Way. The resident was concerned there was broken glass being hidden at the site and there was a risk of fire. Alison reported this to the anti-social behaviour team at ADC.

There are no updates on previous reports of anti-social behaviour in the village.

4. Freedom of Information / Data Protection requests

No Freedom of Information or Data Protection requests received since the last report.

5. East Preston Men in Sheds, 6th September

I attended this meeting at the British Legion.

Chairman Neil Ellis led the meeting which was attended by the hardcore of interested men plus a potential new member. The meeting agreed a constitution and set an initial membership fee of £20. Most attendees joined up there and then.

6. Her Majesty, Queen Elizabeth II

Within ninety minutes of the announcement of the death of Queen Elizabeth II, I had met Cllrs Toney and Linton at the Council Office, from where we joined Cllrs Duff and Chapman outside the library. Cllr Toney raised a virgin flag reserved specifically for this occasion and immediately lowered it to half-mast. Whilst still in the office, Cllr Toney wrote a statement which was added to the council's Facebook page that evening, together with a landing page marking the Queen's passing. Meetings scheduled for what we believed would be a mourning period of ten days were cancelled.

On the following morning, I set up the book of condolence in the meeting room and sorted out a window display. Cllrs Toney and Linton joined me in the Council Office to make sense of the council's own plan of what to do in the event of the death of a senior member of state and other sources of information which were trickling through. Understanding the Friday to be Proclamation Day, Cllrs Toney and Linton raised the flag back to full mast at 11:00, as per protocol, preparing to re-lower it to half-mast at 12:45 on the Saturday, enabling Cllr Toney and I to attend Doug Medhurst's Thanksgiving Service at 13:00. I placed a post on

Facebook to explain why the flag had been raised back to full mast. Our thanks to East Preston resident and Deputy Clerk at Rustington, Rosie Costan, who had noticed Proclamation Day had been put back to the Saturday as a result of the lateness in the day at which the announcement of the Queen's death had been made on the Thursday. Cllr Toney duly lowered the flag back to half-mast.

The council was thanked by the Chairman and the Clerk of Kingston Parish Council for lending it a Union Flag whilst the council's Flag Officer was away from the village. Kingston Parish Council has said it will order us a replacement flag rather than simply returning the one we have lent.

Meanwhile, at Cllr Toney's suggestion, a black ribbon wreath was tied to the Platinum Jubilee tree on the Village Green. This resulted in Facebook comments such as: "A very touching thought," "Such a thoughtful thing to do," and "Oh wow!". Subsequently, members of the public have started to add their own floral tributes around the base of the tree.

A book of condolence was made available in the Council Office from the morning of Friday, 9th. On the first morning, this was signed by several councillors and two members of the public. It was agreed this (main) book of condolence would be transferred to the library from lunchtime on Monday, 12th. A second(ary) book of condolence would be mobile and taken into any care homes which accepted the council's offer to do so; Cllr Gunston took the book to Green Willow and Cllr Linton took the book to The Martlets. This second book of condolence was available in the Council Office for two hours on the evenings of 13th and 15th September; nobody attended on the evening of the 13th (thanks to Cllr Gander for keeping me company for an hour) and one person attended on the evening of the 15th (thanks to Cllr Gunston for keeping company initially and to Cllrs Chapman and Duff for coming in to do some council work during the session).

With Saturday, 10th September being Proclamation Day, Cllrs Toney and Linton and I returned to the library and raised the flag back to full mast at 11:00. Having agreed the council did not need to undertake a local proclamation, as national proclamations were televised and all over social media, a low-key re-lowering of the flag to half mast was scheduled for 15:00 on Sunday, 11th September. Unexpectedly, District Cllr Kelly and Mrs Kelly attended this.

Returning to work on the day after the funeral, I dismantled the window display. In an enewsletter later that day, I said the Books of Condolence would be available upon request, although officially closed. Some more residents did call in to sign, and I was particularly touched all committee members of East Preston Men in Sheds signed the book when they attended a committee meeting in the office on 21st September. In due course, a letter will be sent to King Charles III advising him the Books of Condolence would be deposited at West Sussex Record Office.

Cllr Linton, Alison and I collected the floral tributes from around the base of the Platinum Jubilee tree on Monday, 26th September.

7. Thanksgiving Service for the life of Doug Medhurst, 10th September

Cllrs Toney, Mathias and Moore and I attended this event at St Mary the Virgin Church. To say the great and the good of East Preston were also there would probably be an understatement. Readers may remember Doug had died during the first lockdown at which time it was impossible to have the sort of funeral and wake he richly deserved.

The event was organised by Doug's younger daughter, Alison, and she was the first of five speakers each remembering a different aspect of Doug's life. Alison unsurprisingly spoke of Doug as father and family man. Fr John Kimberley spoke of Doug's faith and life within the church. Joan Crane talked of Doug's contribution to East Preston schools. Dorothy Lee described Doug's time on the Parish Council, and finally, Paul Amoo talked about Doug's

time leading and supporting the East Preston Festival. There were also poems, readings, hymns and one resident who stood up and, spontaneously, recited the lyrics of *I Remember It Well* from *Gigi*, a song she and Doug used to sing together.

A good eighty to one hundred people adjourned to the Village Hall for a traditional afternoon tea. It was a mark of the high esteem in which Doug was held the former editor of the Littlehampton Gazette, Roger Green, had travelled from Derbyshire to attend.

The council lent Alison a projector and screen on which photographs from throughout Doug's life were shown.

8. Installation of the Platinum Jubilee Clock, 21st September

Finally, after several false starts, everything was in place to install the clock on Wednesday, 21st September. We had the right licences and permissions from WSCC, Cllr Toney had the right New Roads and Street Works Accreditation, the clock manufacturer had access to a HIAB lorry, we were ready.

Cllrs Toney and Linton and I attended at the agreed time of 09:00. Cllr Toney had, in fact, also attended late the previous evening to cone off an area for the HIAB lorry to park adjacent to the clock site, and again at 07:00 to ensure the cones had not been moved. Two Enerveo engineers were in attendance from before 09:00 to carry out the necessary electrical connection work. Cllrs Toney and Linton and I were mainly on hand to answer any questions from anyone connected with the installation or from members of the public, and also to get involved with any traffic management, vehicular or pedestrian, to ensure no members of the public were at any risk during the installation work.

The clock manufacturers only arrived at 09:45, held up on the A27. As the northern shopping area was very quiet that morning, the council reps agreed I was not needed, and I returned to the office before the clock arrived. The installation work completed at about 13:30 having mainly gone smoothly – Cllrs Linton and Toney can advise further on this.

For information, the clock is radio-controlled so should always show the right time and need no manual intervention at the start and end of British Summer Time. The clock has been added to the council's insurance cover with immediate effect.

9. Platinum Jubilee Clock feedback

10. Interim internal audit for the year ending 31st March, 2022, 21st September

Originally scheduled for 19th September, this visit had to be rapidly rescheduled once the date for the Queen's funeral was announced. With limited time available due to the number of other councils he needed to audit, Andy Beams was only able to attend on the afternoon of 21st September or late in December. Andy's report appears elsewhere on the Agenda for this evening's meeting. When he was scheduled to visit on 19th September, Cllrs Mathias and Wilkinson were going to meet with him as representatives of the Audit & Governance Committee, representing the council as a whole. On the day, Cllr Wilkinson was out of the village and unable to attend at short notice, but Cllr Mathias did attend and will report back.

11. Rampion Visitor Centre visit, 23rd September

Just to say I joined this visit with Cllrs Chapman, Duff and Gunston and also Cllr Buckenham of Kingston Parish Council.

We were at the centre for about an hour, guided around by Anthony and Tam. Although small inside, a lot of interactive displays are available and the hour flew by. Perhaps

ironically as one of the reasons some people do not want the windfarm expanded is the visibility of the turbines, on this day, although reasonably clear, the turbines were all but invisible.

12. East Preston Beach Clean No. 18, 25th September

The first council Beach Clean this year as the one scheduled for April was cancelled because of the weather.

About thirty members of the public took part alongside Cllrs Toney, Linton, Bradshaw, Chapman, Duff and Gander. The weather was lovely, bright and sunny.

Once again, there were not huge amounts of rubbish to collect, but items retrieved including bits of scaffolding, some coconuts, some clothing, a bit of hardcore, bottles and so on.

Thanks to Arun District Council and KEPT for lending us useful equipment and to Melanie and her team at SALT Kiosk for sponsoring the refreshments for the event.

Rampion Visitor Centre visit, 23rd September

Brighton

On 23rd September, Cllrs Chapman, Duff, Gunston together with our clerk and Cllr Keith Buckenham from Kingston Parish Council visited the Rampion Visitors Centre in Brighton. We were welcomed by Anthony and Tam who gave us a quick overview of how wind farms work before allowing us to play with some of the interactive exhibits. Simon managed to successfully design his own wind farm and we all experienced the virtual reality of a visit to one of the turbines.

The centre, although small, contains displays on the history of electricity and effects of climate change as well as details of how the existing Rampion wind farm was built and how it works. Anthony was happy to answer our questions on how efficient the wind farm is and what effects it has had on sealife - power is produced 85% of the time and 38% of the time at full power as opposed to around 42% in the North Sea and according to anecdotal evidence sealife is flourishing.

An hour well worth spending if you are ever on Brighton seafront.
