#### 674/23 EAST PRESTON NEIGHBOURHOOD PLAN (EPNP) REVIEW

Oneill Homer had let the Clerk know a new funding window had opened for councils undertaking a review of an existing Neighbourhood Plan. He had let Cllr Bowman know of this, Cllr Bowman was currently interim chairman of the Neighbourhood Plan Review Steering Group. Cllr Bowman wanted this committee's support the Steering Group could apply for a grant. The committee AGREED unanimously the Steering Group should be encouraged to apply for this funding.

The Clerk had received a letter from Middleton-on-Sea Parish Council which was just preparing its first Neighbourhood Plan. As such, it was suggesting an "informal network with no subscription chares, merely a structure information hub" be created, operating "via periodic Zoom based discussed and occasional Zoom based seminars." The letter said such networks already operated in Berkshire, Horsham District and London, to good effect. The committee AGREED unanimously this council should be represented in such a network, and proposed Cllr Bowman be the council's representative (with her agreement).
