031/25 MATTERS ARISING FROM PREVIOUS MEETINGS

<u>Minute 951/25 – Licensing Applications</u> – the Clerk had sought clarification from ADC Licensing on what the committee perceived as unfairness between the licences granted for outdoor drinking for two venues in the southern shops, one of which was allowed to serve drinks outdoors until 23:00 seven days a week, the other only allowed to serve until 23:00 two days a week, 22:00 the other five days. The Licensing Officer had explained each application was considered on its own merits, that ADC did not suggest times to applicants (nobody had suggested they did) and no one business needed to pay heed to another business's hours when making its own application. When the Clerk had replied this council had merely wanted to see Licensing laws applied fairly, which did not appear to be the case here, no further reply had been received.

The committee AGREED unanimously Cllr Bradshaw could, in due course, approach the licensee of the second business and alert her to the discrepancy.
