### 176/25 EAST PRESTON NEIGHBOURHOOD PLAN (EPNP) REVIEW

Cllr Bowman, also chairman of the Neighbourhood Plan Review Steering Group, confirmed the Steering Group had received an indicative housing number of 10 from ADC. This would be fed back to Neil Homer together with some questions the team needed him to answer.

The meeting discussed what maps it should include in the final reviewed Neighbourhood Plan. Cllr Bowman said she had moved all maps into Appendix C. After some discussion, the committee AGREED to keep the character areas as a single map, preferably using the 2015 version as that was higher definition than the 2008 version which had somehow found its way into the 2015 Neighbourhood Plan.

Cllr Bowman was once again hopeful a version would be able to go out to consultation soon.
