365/25 <u>EAST PRESTON NEIGHBOURHOOD PLAN (EPNP) REVIEW</u>

Cllr Bowman, also chairman of the Neighbourhood Plan Review Steering Group, reported the committee of East Preston & Kingston Village Hall Foundation had expressed concerns about the continued inclusion of the Conservative Hall as a community venue within the draft revised Neighbourhood Plan. The Planning & Licensing Committee AGREED unanimously it was right to keep the Conservative Hall listed as a community venue as the new owner had publicly said the venue will still be available for hire by community groups. Cllr Bowman had asked the Village Hall committee to include its comments as part of its response to the stakeholder consultation on the revised Neighbourhood Plan.

366/25 TERMS OF REFERENCE

The committee undertook the annual review of its Terms of Reference. The Clerk had proposed a small change to §2.9 regarding arboricultural Applications. The Clerk had also proposed to withdraw reference to the West Sussex County Council Structure Plan 2001-2016 from §5.6 as a search of the WSCC website did not throw up such a document.

The committee AGREED unanimously to agree to the proposed Terms of Reference for the committee. These will form v6 of the committee's Terms of Reference.
