Playground Enhancements

The Amenities Committee is pleased with progress on a current project to enhance the Children's Playground and car park area at the Warren Recreation Ground.

Multi-coloured metal fencing has now been erected around the playground which should prove more durable than the previous wooden fencing. The fencing has also been straightened at the eastern end to expand the playground to take an extra piece of equipment. The Amenities Committee is still considering a suitable piece of equipment for the additional space but it is hoped a decision will be made at its September meeting.

Parking changes in Worthing Road

Hopefully some good news for the residents of the western part of Worthing Road.

At the 30th June meeting of the West Sussex County Council Joint Eastern Arun Area Committee (JEAAC) a Traffic Regulation Order (TRO) was agreed upon and will come into force in the coming months.

For a long time, residents of Worthing Road have complained about rail users parking at the western end of the road. Some just park there for the day whilst others for weeks when going on holiday.

This can cause problems for residents trying to exit their driveways, can delay bus services as two buses cannot pass whilst vehicles are parked, and can create dangerous situations for drivers, cyclists and pedestrians.

Two public consultations have been held following publication of the proposals, and local views have been taken into consideration before a decision was made.

So what is going to happen?

On the southern side of Worthing Road almost to the western side of Copse View there will be No Waiting between 10:00 - 11:00 am and 2:00 - 3:00 pm from Monday to Saturday inclusive.

On the northern side and around both sides of Copse View No Waiting at any Time will come in force.

The southern side of the T-crossing with The Street and Worthing Road also will be a No Waiting zone at any time.

We realise that the current parking problem will move to other areas as many people do not want to pay to use the car-park at Angmering Station. At a later stage there will be a review of parking issues in a much wider context between Rustington, Angmering and East Preston.

Pro gym equipment without the fees

The outdoor gym equipment installed on the Warren Recreation Ground is now in use and being enjoyed by people of all abilities.

The equipment has been donated by the East Preston Film Society, which bolstered its own fundraising work with grants from West Sussex County Council and One Stop Stores. The equipment is recommended for use by those over 11, and usage instructions are attached to each piece of kit. Chairman of the Film Society, Paul Amoo, said, "We are delighted to have been able to donate this equipment to the village and



thank the Parish Council for its co-operation. The society is currently having a summer break, and films will start again on 10th October, again sponsored by Cooper Adams."

East Preston - a great place for doing business!

The East Preston Business Community is a group of East Preston businesses that have joined forces to raise awareness of just what a great place East Preston is for doing business. There are over 160 businesses in our village and we formed the East Preston Business Community to let more people know more about more local businesses.

After discussing a number of ways of promoting East Preston as a great place to do business, it was felt local people were not fully aware of the huge range of trades, professions and products are available on their doorsteps. With that in mind, we set about devising a method of letting folks know exactly how convenient East Preston is. We felt a positive way of promoting ourselves was to have a dedicated website **www.ep-bc.org** where you can view information about a particular business, see the proprietor and get useful contact details and links too. In such a diverse village not everyone has access to the internet so we felt a printed directory was an essential part in making ourselves known; this has proved very popular. A259 Improvements

Major improvements are planned for the A259 between the Tesco roundabout in Littlehampton and the Goring roundabout.

In a nutshell this part of our main artery will become a dual carriageway within the next two to three years if everything goes to plan.

West Sussex County Council commissioned experts to study traffic flow on this section of the A259 and to suggest improvements. The county council's Joint Eastern Arun Area Committee (JEAAC) and its Highways and Transport subcommittee have been heavily involved in the study. The proposal has been discussed and commented on several times and the results of the study are almost finalised.

Original estimated costs were about $\pounds12$ million, but the final version is now about $\pounds22$ million. Most of the funding is in place and work may start towards the end of 2016.

The works will be phased and the projected first stretch will be that between the junction with Station Road and the junction with the Angmering by-pass as this is recognised as the largest bottleneck. These works are not expected to cause too many disruptions for traffic as where possible, the current lane will stay in place and the new dual option will be built alongside.

For the time being, West Sussex County Council has put our Roundstone Level Crossing study on hold, as it believes most of the current traffic flow in that area will change dramatically following the improvement above.

The impact of the proposed and partly-approved new homes schemes around our area is only partly integrated into the proposal. Hopefully the proposed A27 Arundel improvement will have a positive effect in conjunction with the Lyminster bypass.

Blooming Marvellous

Earlier this year the Friends of Langmeads, supported by Arun District Council and with help from pupils of both East Preston Infant School and East Preston Junior School planted a poppy meadow in Langmeads Field "to commemorate the millions of people who lost their lives in the First World War."

Thanks to Bob Billinghurst of Refined Images for this evocative photograph of the poppy meadow in early July.

The poppies have now died back and their place taken by a lovely range of other wild flowers. Well worth a visit if you can.



East Preston Untouchables 6-a-side football team crowned Champions

An East Preston-based 6-a-side football team recently won the Worthing Sunday Leisure Leagues Division 1. The Untouchables were crowned champions after winning eleven of their fourteen games, drawing once and only losing twice. One of their players - Eli Amoo - won the accolade of Player of the Season.

The Untouchables captain, Isaiah Amoo said, "We are all so happy with our achievements as a team. We are now promoted to the Premiership Division after our first season which will be a challenge but with the squad we have I have high hopes for us."

The Untouchables was founded in 2009 by Isaiah along with other young local East Preston residents Eli Amoo and Nick Jones. Isaiah said "Before this year we were just playing tournaments every now and again but we wanted a regular challenge". The team was created to allow a group of boys who played regularly on the Village Green to test their abilities against others. On reaching the minimum age allowed for participation in the Worthing Sunday Leisure Leagues, the search began to find a kit sponsor as the cost to them of kitting out the team and match fees was prohibited.

"It was just by chance that whilst reading up on grants, I came across the East Preston Parish Council Grant Aid application and wondered if we were eligible. The application was successful and a £500 grant was received which has been used to buy football



Dogs Update

One of residents' biggest concerns in the village-wide survey we carried out in 2012 was irresponsible dog ownership manifesting itself through dog mess not being cleared up.

Over the summer, the council has again purchased Dog Warden resource through Arun District Council, and probably many dog owners will either have seen the warden or spoken to him. We know the problem tends not to happen during the day so we have also asked for latenight and early-morning visits.

This, in conjunction with the fluorescent-spraying of dog mess around the village, will hopefully have a positive impact upon this problem.

The Littlehampton Gazette recently reported on a case where an irresponsible dog owner, aged 80, was heavily fined for not clearing up after their dog – a sobering thought for those of all ages responsible for dogs.

In the past, the council has been very supportive of the Community Speedwatch initiative which allows groups of people across the country to be active in monitoring traffic speeds in their communities.

ENGINE IDLING AT LEVEL CROSSINGS MAKES ME FUME!AND MIGHT MEAN A FINE FOR CULPRITS

If you wait in your car at either of the village's level crossings, do you keep your engine running? Did you know that if you do, you might be breaking the law?

Despite the signs telling drivers to switch off engines if waiting when the gates are down, many don't. I have seen some drivers sit there, with their cars and vans spewing exhaust fumes for 10 minutes.

Stationary idling is an offence under section 42 of the Road Traffic Act 1988. The Act enforces rule 123 of the Highway Code which states: 'You must not leave a vehicle engine running unnecessarily while that vehicle is stationary on a public road.' Doing so can incur a £20 fixed-penalty fine.

And if that's not reason enough, spare a thought for the children walking or cycling to and from the local schools - they often have to wait at these crossings. Let's not "reward" their decision to go to school in a "green" manner by subjecting them to unnecessary fumes.

The environment will benefit and you will save money - research shows that just 10 seconds of engine idling uses more fuel than restarting.

It takes just a couple of seconds to start a car engine, so it begs the question: **Why on earth would you leave the engine running while you wait?!**

Please don't be idle about engine idling - heed the signs and switch it off! (AB)
