With approximately 3,000 delightful properties and a population of over 6,000, East Preston is a wonderful place. Because of this dilemma, East Preston Parish Council initiated monthly informal Business Breakfast meetings to support local businesses. These give businesses an opportunity to network and raise their profile.

East Preston's first blue plaque

On a bright Saturday afternoon in November, a small group of people gathered outside Far End in Sea Lane. There, Mrs Shirley Zangwill unveiled a blue plaque in honour of her parents-in-law, Israel Zangwill and Edith Ayrton. Mrs Zangwill said, "I thank East Preston Parish Council so much for asking me to unveil the Blue Plague to honour Edith and Israel Zangwill. It was a fantastic occasion for me and I enjoyed every minute of it, meeting so many lovely and interesting people. Such a wonderful day."

This is the first blue plaque in the village and its unveiling in 2018 was particularly apt as both were lifelong campaigners for women's suffrage and world peace. Emmeline Pankhurst is believed to have stayed in the house at the height of the women's suffrage movement.

A question to responsible dog owners

Like many councils across the country, this council receives complaints from residents about the amount of dog mess which is not cleared up by owners - both on pavements around the village and on greenspaces such as the Warren Recreation Ground and Village Green. Some residents have called for a ban on dogs on these open spaces.

When we take action to highlight the problem, such as spraying uncleared dog mess with fluorescent paint, we then receive a different set of complaints from residents who think the patches of bright paint are also unsightly and stay around long after the dog mess has been removed.

We believe the majority of dog owners in the village are responsible, clearing up after their dogs, proving it is not a difficult thing to do.

So this is a question to the responsible dog owners in the village. What ideas do you have for how this council can tackle this problem? Any suggestions made will be considered by the council.

East Preston Parish Council council tax for 2019/20

Each year, this council spends money in the village and that money is part of the council tax you pay annually to Arun District Council. The money raised through the council tax which this council can spend is called the precept.

East Preston councillors devote a lot of time to keeping East Preston a lovely place to live and part of that is spending time building a budget each year to encompass both short-term and long-term projects. At the January Full Council meeting, the council agreed an annual increase of £7.15 to £95.10 per year for a Band D property. This equates to an increase of less than 14p a week. For those who prefer such figures in percentage terms, that is an increase of 7.5%. The council appreciates this is above the most recent rate of inflation, but please rest assured the council did not agree this lightly - every line of the council's budget is considered by the relevant committee before a figure is recommended to the council.

Despite the increase, the council's budget will still be higher than the amount raised from your council taxes in the coming financial year. The council will dip into its reserves to address this shortfall. Some of this shortfall

News from the Friends of St Mary's Church

Following many requests over the past two years, we have agreed to run a third Christmas Tree Festival in the church later this year. This will run over a weekend leading up to Christmas. We plan to make it bigger and better than before, maybe extending out into the churchyard. The 2016 Christmas Tree Festival raised just under £10,000 and attracted 2,000 visitors. We hope you will agree this is something to look forward to.

This is all part of the Friends campaign to raise about £100,000 for essential repairs to maintain the Grade I-Listed building in a good, useable state. We believe this is important for almost everyone in the village, whether they are getting hatched, matched or despatched or just attending one of the social events we run throughout the year.

The Friends intend on launching an appeal in about September of this year. All funds raised by the Friends goes solely towards expenditure on the building itself. The building's Grade I-Listed status means it is a very expensive building to maintain, but it's worth it. will also be addressed by the increased amount of interest the council has been earning on its reserves over the past couple of years thanks to regular reviewing of its bank accounts to ensure the council's reserves are working hard for the village.

The over 800 residents on the council's e-mailing list were once again given the opportunity to comment upon this increase in the days leading up to the council meeting. Only one resident chose to comment and his comments were seen by the council prior to the meeting.

This increase in the council's budget is mainly related to the need to increase the council's staffing profile as reported in the Autumn 2018 Newsletter, delivered to homes during November. This time last year, we had hoped the refurbishment of the toilets in Sea Road would have been completed, but despite best efforts that has not yet been possible. The council has delivered, in the past year, the multi-use games area at Lashmar Rec, a successful Food & Drink Festival and a successful Christmas Celebrations event, both enjoyed by many residents, a playscheme for younger children, all from an office which helps numerous residents on a very wide range of issues and concerns.
